The Wilkinson County Board of Commissioners met in a Call Session at 10:00 A.M on MAY 28, 2020 in Commissioners Chambers. The following Commissioners were present: Chairman Gotell, Commissioner Pete Williams, Commissioner James Hagins and Commissioner Glen Kester and Commissioner John Williams.

Invocation

Chairman Gotell asked Commissioner John Williams, District-4 to lead the invocation.

Motion carried there were none opposed.
